

# Members of the Bipartisan National Council on Election Integrity Call on Congress to Adequately Fund Election Security

Dear Members of Congress,

We write to call for the appropriation of at least \$400 million in Election Security Grants for FY2024. On March 24, 2023, the Co-chairs of the National Council on Election Integrity wrote to the chairs of the relevant appropriations committees and subcommittees to call for this critical funding to protect our nation's elections from foreign interference efforts and growing cybersecurity threats. Today, we renew this call and extend it to all members of Congress with a specific emphasis on the importance of funding to counter cybersecurity threats. The National Council on Election Integrity is a bipartisan group of former government officials and national security leaders united to defend the legitimacy of our free and fair elections. We are particularly concerned that state and local election officials need robust federal funding to protect our voting systems from cybersecurity threats.

Congress has a Constitutional duty to secure federal elections, and the American people overwhelmingly support appropriating federal funds to do so. A recent poll conducted by Citizen Data, in partnership with Issue One, revealed that 69% of Americans believe that the federal government should be just as, or more, responsible for election funding than local municipalities and states. **The same poll found that 74% of Democrats and 66% of Republicans support federal funding of elections.** 

Thanks in large part to federal support in previous appropriations, state and local election officials have taken important strides towards improving their cyber preparedness. Repeated testing has demonstrated that voting machines and tabulators are not themselves vulnerable to online manipulation. Meanwhile, local, state, and federal partnerships like Illinois' Cyber Navigator Program and Florida's Joint Election Security Initiative have built layered governmental capacity to respond to cyber threats. However, effectively countering cybersecurity threats requires high levels of technical expertise and up-to-date technology. Adversaries' capabilities continue to evolve and improve, but federal support for state and local election officials has not increased to meet this dire need.

Foreign and domestic bad actors have demonstrated the capacity to cast doubt on the legitimacy of a safe and secure election through advanced AI-fueled disinformation, cyber attacks on registration systems, malign finance operations, and targeting of electrical systems during critical voting or tabulation periods. The lack of adequate federal funding to match the cyber threat has left our election system at increasing risk. These funds could be used to train and hire cyber-capable staff or purchase, install and maintain security measures like network monitors and two-factor authentication.

We strongly encourage bipartisan action to appropriate at least \$400 million in election security funding — with at least fifty percent going to local election offices — as a matter of urgency to bolster the security and integrity of the 2024 elections.
