**RE: Issue One's ReFormers Caucus Calls on the House to Pass Bipartisan Legislation to Ban Insider Trading in Congress**

Dear Speaker Johnson and Leader Jeffries:

We, the undersigned former elected officials, write to urge House leadership to bring the Restore Trust in Congress Act ([H.R. 5106](#)) to a floor vote and strongly recommend attaching this legislation to a “must pass” package before the conclusion of the year. Passage of the Restore Trust in Congress Act would eliminate the persistent appearance of insider trading among members of Congress.

Insider trading by elected officials has been an ongoing and bipartisan issue for years, garnering attention among policymakers of both parties to put a stop to the practice. A recent Wall Street Journal [analysis](#) revealed a surge in stock trading by federal lawmakers and their families in early April 2025 amid the rollout of President Trump's new tariff policies. To make matters worse, [sitting members](#) who ran for elected office campaigning on banning insider trading, have turned their backs on their promises.

Public [trust](#) in the federal government is at historic lows. Enacting this critical reform would be a powerful step toward rebuilding that trust, addressing real and perceived conflicts of interest, and demonstrating that members of Congress prioritize the institution's integrity and their commitment to their constituents above personal gain.

Public opinion is overwhelmingly on the side of reform: A University of Maryland survey [found](#) that 86% of Americans support prohibiting members of Congress from trading stocks. A similar [study](#) from the Rady School of Management found that public exposure to reports of members of Congress trading stock significantly reduces Americans' trust in the institution, as well as their willingness to abide by the law.

Leaders in both chambers have introduced several stock trading ban bills in recent years, but they've remained stagnant due to partisan disagreements. The Restore Trust in Congress Act transcends that divide, emerging from months of [negotiations](#) between a diverse group of members

of Congress to find common ground. Issue One's ReFormers Caucus [applauded](#) Representatives Chip Roy (R-TX), Seth Magaziner (D-RI), Brian Fitzpatrick (R-PA), Pramila Jayapal (D-WA), Tim Burchett (R-TN), and Alexandria Ocasio-Cortez (D-NY) for leading consensus efforts in the name of restoring trust in our government. This illustrates the bipartisan energy behind the negotiations, with members from the right, left, and center coming together on behalf of the American people.

The bipartisan Restore Trust in Congress Act would:

- Prohibit all members of Congress, their spouses, dependent children, and their trustees from owning, buying, or selling individual stocks, securities, commodities, or futures, with clear exceptions.
- Prohibit covered individuals from purchasing covered assets and require them to divest from all covered assets at fair market value within 180 days for sitting members and 90 days for incoming members.
- Allow the supervising ethics office to impose and enforce penalties — including disgorgement of profits, public disclosure, and disciplinary actions.

Earlier this year, the House Freedom Caucus [listed](#) banning members of Congress from trading individual stocks as one of their policy priorities in a letter to Republican colleagues. Similarly, we acknowledge that both of you have expressed [support](#) for this [reform](#) in your leadership roles.

More recently, Treasury Secretary Scott Bessent [called for](#) such a prohibition and the Senate Homeland Security and Governmental Affairs Committee [advanced](#) bipartisan legislation to this effect.

As former members of Congress from both parties, we're deeply committed to the ongoing health of our democracy and the institution of Congress. The American people understand that our elected lawmakers cannot be both the referee and the player – that presents a clear conflict of interest. Even the appearance of self-dealing does damage. That is why we encourage all sitting members to support this critical reform by signing on to the Restore Trust in Congress Act and ensuring its passage before the end of the year.

Thank you for your attention to this critical reform.
